

## **HIGHWAY 119 METROPOLITAN DISTRICT NOS. 4-10**

### **CONSOLIDATED 2021 ANNUAL REPORT TO THE TOWN OF FIRESTONE**

9. Intergovernmental Agreements with other governmental entities either entered into or proposed as of December 31 of the prior year.
